It should not be exaggerated to say that Uzbekistan today also stands at such a crucial crossroads in history. Consequently, the strategy of action developed by President Shavkat Mirziyoyev becomes a national lecture, representing an important and new stage in the fate of our perspective.

The strategy covers concepts related to the organization of management, aimed at forecasting and overcoming crisis situations arising in the economic, socio-political and other spheres of the world and internal life of the state. Just as ideology cannot be copied, so the strategic goals of a State cannot be copied or copied from the historical experience of other States and peoples. After all, every nation has its own political, social, demographic, economic, cultural, historical, and natural resources. It is these factors that create certain social conditions and opportunities. The strategy of our country is manifested not only in a step towards reforms in domestic and foreign policy, but, above all, in changing the attitude of the state to the people, the people to the state. Strategic directions are defined as the main goal of the state, so that any person living in our country, regardless of nationality, language and religion, lives freely, peacefully and richly, enjoying life today. Ensuring decent education for young people, arming them with modern professions, ensuring public health, supporting people with disabilities, people who have lost a breadwinner, elderly people in general in need of help, was confirmed in the Message of the Head of our State to the Oliy Majlis dated December 28, 2018. State and social construction is such a complex structure that requires the simultaneous intensive development of interrelated and complementary spheres and fronts in its structure. Each

of them creates the basis for the other. Of course, this requires solving such tasks as taking into account the specifics of each industry in the process, objective analysis, timely adoption of appropriate measures, creation of legal foundations for their development, organization of effective functioning mechanisms based on new technologies.

In the action strategy of President Sh.M.Mirziyoyev, the implementation of the principle "The people must serve our people, not state bodies" is also embodied in the program goals of socio-political life. [3-16]

Therefore, to develop a draft joint resolution of the kengs of the chambers of the Oliy Majlis on radically improving the activities of the Legislative Chamber and the Senate of the Oliy Majlis of the Republic of Uzbekistan to study the state of affairs on the ground and interact with the people, in which deputies and senators elected from the regions will stay in the same area monthly for 10-12 days, analyzing the activities of state authorities. The relevant leaders are to submit their reports to the session of People's Deputies for discussion and draw appropriate conclusions, and also, following the meeting with the participation of the Speaker of the Legislative Chamber and the Chairman of the Senate, it is planned to hold sessions of the relevant Councils of People's Deputies, the Senate of the Oliy Majlis organizes the alternate work of exemplary Councils of People's Deputies in each region. If we pay attention to the fact that the parliament, acting on the basis of the will and interests of the people, as well as passing laws, is one of the main democratic values, the interaction of deputies and members of the Senate with the voters of the Republic, awareness of local problems, participation in their solution, assistance to the revival of local representative bodies will create more favorable conditions for the development of civil society in our country. Because a deputy of the highest representative body primarily represents citizens in the constituency, and a member of the Senate represents local government bodies of the region in which he is elected. Therefore, the more active activity of members of Parliament among the people serves as one of the factors for further strengthening the stability of our state.

And to ensure the interests of a person, first of all, it is necessary to communicate with people, with the people, a good knowledge of their problems, dreams, life problems and needs. [4-14]

Therefore, based on the most basic principles of civil society, in order to organize a dialogue between the government and the people in the management of the state, timely study and resolution of issues of concern to citizens, problems, at the first stage of the 2017 state program, it was planned to organize effective dialogue mechanisms, and at the same time these plans are being implemented.

As a result of a wide public discussion, in the decree of the President of the Republic of Uzbekistan dated 01/28/2022 No. PF-60, a new development strategy of Uzbekistan for 2022-2026 was adopted, consisting of the following seven priority areas developed on the basis of the principle "from action strategy to development strategy" (hereinafter referred to as the development strategy) and called the "development strategy" implementation

was approved the state program for improving the standard of living of the population. They consist of:

creation of a people's state by increasing the value of a person and further development of a free civil society;

the transformation of the principles of justice and the rule of law in our country into the most important and necessary condition for development;

ensuring accelerated development of the national economy and high growth rates;

implementation of a fair social policy, development of human capital;

ensuring spiritual progress and bringing the industry to a new level;

an approach to universal human problems taking into account national interests;
